The articles of incorporation of the Democratic Professionals Forum of Palm Beach County, Inc., are hereby amended to read as follows:

ARTICLE III IS HEREBY AMENDED TO READ AS FOLLOWS

Purpose

The corporation is organized and shall be administered and operated exclusively to operate as a political organization within the meaning of Section 527 of the Internal Revenue Code of 1986, including the following:

- (1) To engage in activities permitted of political organizations exempt pursuant to Section 527 of the Internal Revenue Code;
- (2) To engage in fundraising relating to the carrying out of the goals of the organization, including the hosting of public forums for Democratic leaders and elected officials.

ARTICLE IV IS HEREBY AMENDED TO READ AS FOLLOWS

Membership


The Corporation shall have two classes of members. Class A member(s) shall have all rights described in these Articles and the Bylaws including the sole right to amend these articles. Class B member(s) shall have no rights other than honorary membership. The initial Class A members shall consist of Bryan S. Miller and such other persons as shall be elected to membership in the manner determined by the Bylaws of the Corporation. The directors need not be members of the Corporation unless so required by the Bylaws.

This amendment is hereby adopted by the Board of Directors on February 13, 2006.
