# Article (3) Purpose for Which This Ministry Was Designed: Quincy Lamar Perry's Holy United Transition Over The Gap Ministries Inc.

Purpose, Is being formed to provide all forms of Christian services permitted under state and federal laws, including but not limited to the spiritual empowerment of God's people, Missions, Ministry training, Outreach programs and Services targeting at risk communities. The Quincy Lamar Perry's Holy United Transition Over The Gap Ministries Inc. plans to operate exclusively as an exempt organization within the meaning of section 501 (c) (3) of the Internal Revenue code of 2005.

# Article (4) Powers

Quincy Lamar Perry's Holy United Transition Over The Gap Ministries Inc.

Shall have the power to acquire, own, maintain and use it's assets, donations for the purposes for which it has been organized to raise funds by any legal means for the encouragement of it's purposes to acquire, hold, own, use, and dispose of real or personal property in connection with the purpose of the corporation exercise all powers necessary or convenient to the furtherance of the purposes for which the corporation is organized and shall have such other powers as are granted to corporations not for profit but under Florida Statutes and Case laws.

#### **Article (5) Limitations:**

No earnings of The Quincy Lamar Perry's Holy United Transition Over The Gap Ministries Inc. Shall insure in whole or input of the benefit of private individuals or its members, except that reasonable compensation may be paid for services rendered to or for the corporation affecting one or more of its purposes.

Board of Directors shall have the power to enforce the Article by appropriate legislature.

# Article (6) By-Laws:

By- Laws will be adopted, altered, amended, or repealed only by the majority of the Board of Directors with approval and signature of Chris Alvin Perry, as provided in the By-Laws themselves. The By-Laws may contain any provision for the regulation and management of the affairs of the corporation as long as they are not inconsistent with Florida Laws and Statutes or the Articles of the Corporation.

#### Article (7) Manner of Election:

The Board of Directors shall meet quarterly. The manner of election will be by a majority voting process. The Corporation shall have four (4) directors initially. The number of directors may either be increased or diminished from time to time by-laws, but it shall never be less than three. Directors shall hold office for a period of one (1) year and shall be elected at the Annual meeting to be held not later than twelve (12) months from the Date of Incorporations or from the date of the last Annual Meeting.
