


Dear Sir or Ma'am:

I have been asked to contact you on behalf of Braden River High School Band Booster Association, Inc. ("Corporation") regarding the reinstatement of its status as an active not for profit corporation in the state of Florida. As you are aware, the corporation first incorporated last September in 2005. Unfortunately, at the time the annual report became due, the officers of the corporation either did not receive or the annual report notice was inadvertently mislaid and the annual report was not filed with the Secretary of State.
