A Not For Profit Corporation

ARTICLE I

Name: The name of this Corporation is **The Oasis Community Development Program, Inc.**

ARTICLE II

Principal Place of Business: The principal place of business of this Corporation is 920 SE Williston Road; Gainesville, Florida 32641, and the mailing address is the same.

ARTICLE III

Duration: The duration of this Corporation is perpetual.

ARTICLE IV

Purpose: The Corporation is organized in order to engage in any lawful purpose or purposes not for pecuniary profit, to include but not limited to the following: to assist in community development in undertakings projects in concert with private enterprise designed to create and maintain a sound community base, to revitalize the health of established community areas, by enriching the lives of youth and families through education, empowerment and encouragement.

To this end, the Corporation is empowered to perform all acts authorized by law; provided, however, the corporation shall not engage in any activity that is not permitted by a corporation exempt from federal income tax under Section 501 (c) (3) of the Internal Revenue Code, 1986, or any corresponding future provision of the Revenue Code, and

the Corporation shall not attempt to influence legislation by propaganda or otherwise, nor shall it intervene in or participate in any political campaign on behalf of any candidate for public office. No part of the net earnings of this Corporation shall inure to the benefit of any member or private individual, and no member, director, or officer of the Corporation shall receive any pecuniary benefit from the Corporation, except such reasonable compensation as may be allowed for services actually rendered to the Corporation.

ARTICLE V

Membership: Membership shall be defined and determined by the By-laws of the Corporation.

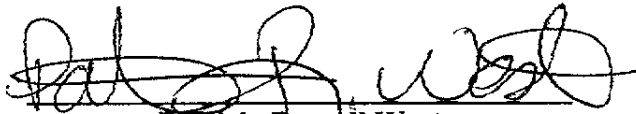
ARTICLE VIII

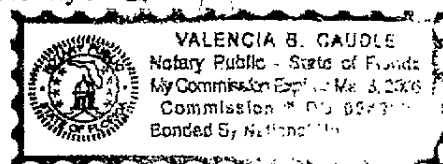

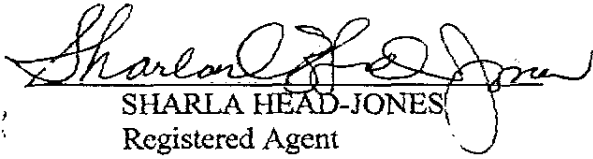
