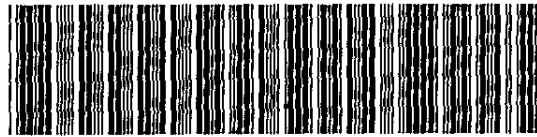

**ARTICLES OF INCORPORATION
OF
HEBRON PRESBYTERIAN CHURCH, INC.**

In Compliance with Chapter 617, F.S., (Not-for-Profit)

Article of Incorporation of the undersigned, a majority of whom are citizens of the United States of America, desiring to form a Not-for-Profit Corporation under the Not-Profit Corporation Law of Chapter 617, F.S., (Not-for-Profit), do hereby certify:

Article 1. The name of the proposed corporation is Hebron Presbyterian Church, Inc.

Article 2. The office of the corporation is to be located in the City of Port St. Lucie, County of Saint Lucie, State of Florida and the initial mailing address is 6039 NW Wolverine Road, Port St. Lucie, FL 34986.

Article 3. The purpose or purposes for which this corporation is formed are as follows:

The purposes for which the corporation is formed are to teach, preach, study the principles of Christianity and perform sacraments; to establish a church for public worship; and to do all things that are compatible with the work and labor of a religious body.

Article 4. The trustees are appointed by the session of the pastor and the ruling elders subject to approval at congregational meeting, which will be held at the first Sunday of the month of January of each year.

Article 5. The names, title, and addresses of initial trustees of the corporation are:

Article 7. The corporation shall comply with Internal Revenue Service, as follows:

(a) In the event of dissolution, all of the remaining assets and property of the corporation shall, after necessary expenses thereof, be distributed to another organization exempt under section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding provisions of any subsequent Federal tax laws, or to the Federal government, or to state or local government for a public purpose, subject to the approval of a Justice of the Supreme Court of the State of Florida.

(b) No part of the net earnings of the corporation shall inure to the benefits of any member, trustee, director, officer of the corporation, or any private individuals (except that reasonable compensation may be paid for services rendered to or for the corporation), and no member, trustee, officer of the corporation or any private individuals shall be entitled to share in the distribution of any of the corporation assets upon dissolution of the corporation.


(c) No substantial part of the activities of the corporation shall be carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by Section 501(h) of the Internal Revenue Code, as amended), nor shall the corporation participate in, or intervene in (including the publication or distribution of statements), any political campaign on behalf of or in opposition to any candidates for public office.

(d) Notwithstanding any other provisions of these articles, the corporation is organized exclusively for one or more of the purposes: religious, charitable, or educational purposes, as specified in section 503(c)(3) of the Internal Revenue Service Code of 1986, and shall not carry on any activities not permitted to be carried on by a corporation exempt from Federal Income Tax under Code Section 501(c)(3) or corresponding provisions of any subsequent Federal tax laws
