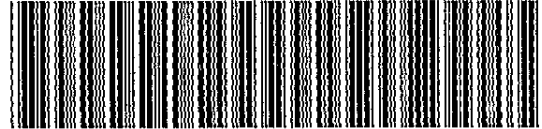

ARTICLE I - NAME

The name of the corporation shall be FAMILIES IN THE NEW MILLENNIUM, INC.

ARTICLE II - PRINCIPAL OFFICE

ARTICLE III - PURPOSE
