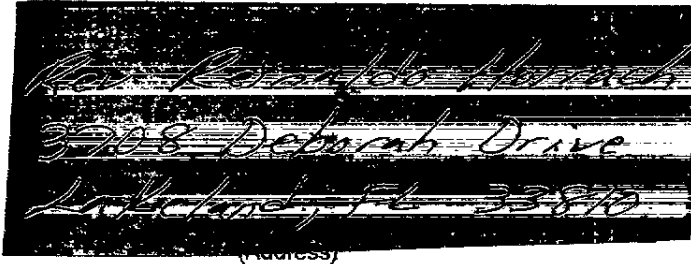

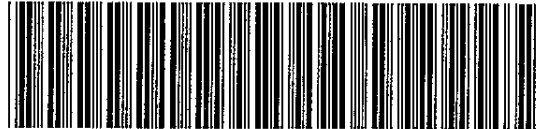

Articles of Incorporation

In Compliance with Chapter 617, F.S., (Not for Profit)

Article I

The Name of the Corporation shall be Vida Abundante Internacional, Florida, Inc.

The period of duration of this Corporation is Perpetual unless dissolved according to law.

Article II

The principal place of business and mailing address of this corporation shall be 3708 Deborah Drive, Lakeland, FL 33810.

Article III

The purposes for which the Corporation is organized are as follows:

1. To teach and promulgate the true religion of the Almighty God as revealed in the Holy Scriptures, and to save souls through preaching, evangelism, missions and education.
2. To advance and promote the cause of Christianity through religious education and training for its members and those attending church meetings, in accord with the teachings, tenets, doctrines and customs of Vida Abundante Internacional; to conduct the affairs according to the Minutes.
3. To conduct and carry on divine services at places of worship, and elsewhere. To establish churches, missions, schools, institutions, and educational institutions throughout the United States and the world.
4. To recruit, train, ordain, and discharge commissioned ministers of the Gospel, and others.
5. To own and maintain suitable buildings and other facilities necessary to fulfill the foregoing purposes, and to do all things necessary with regard to their acquisition (by purchase, gift, legacy, bequest or in any manner), maintenance, upkeep and sale.

6. To receive, manage and disburse funds, gifts and donations for the fulfillment of the foregoing purposes, and to the benefit of Vida Abundante Internacional, its departments, programs, schools and institutions.
7. To borrow money, issue bonds or notes, and all other documents necessary or appropriate to fulfill the foregoing purposes set forth in this Article III.
8. To do all and everything necessary, suitable or proper for the accomplishment of any of the purposes of the attainment of any or more of the purposes herein stated, or incidental to the powers named, or which shall at any time appear conducive or expedient for the promotion of its welfare, and accomplishment of the purposes herein stated.

Article IV

The manner in which the directors are appointed is by pastoral/president appointment.
