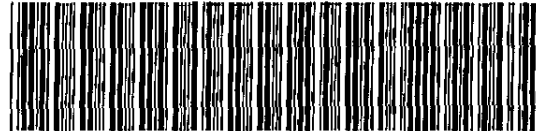

The undersigned incorporator for the purpose of forming a non-profit corporation under the Florida Not-For-Profit Corporation Act, hereby adopts the following Articles of Incorporation.

**ARTICLE I - NAME**

The name of the corporation shall be:

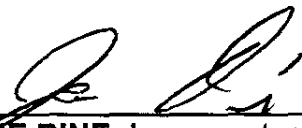

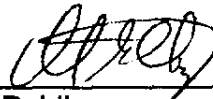
