## AMENDMENT TO THE ARTICLES OF INCORPORATION OF THE PRESERVE AT BAY HILL ESTATES HOMEOWNERS ASSOCIATION, INC.

Section 9 of the Articles of Incorporation of The Preserve at Bay Hill Estates Homeowners Association, Inc. is hereby amended as follows:

9 Board of Directors The affairs of Association shall be managed by a Board of odd number with not less than three (3) nor more than nine (9) members. The initial number of directors shall be (3). Board members shall be appointed and/or-elected as stated in the By Laws. Unless the Board, at a properly noticed Board meeting prior to an election, determines that the Board shall consist of a different number of Directors, the number of Directors shall be the same as the prior year. The election of Directors shall be held at the annual meeting. Directors shall be elected for a two (2) year staggered term as further set forth in the By-Laws expiring in the date of the next annual meeting. Directors shall be elected for a term expiring in the date of the next annual meeting.
