ARTICLE 1 - NAME AND PRINCIPAL PLACE OF BUSINESS

The name of this corporation is SURF N' SAND OWNERS ASSOCIATION, INF, hereinafter called "Association." Its principal place of business initially will be 184 Twelve Oaks Lane, Freeport, Florida 32439 and its initial mailing address will be 184 Twelve Oaks Lane, Freeport, Florida 32439.

ARTICLE V - DIRECTORS

The affairs of the Association will be managed by a board consisting of the number of directors as shall be determined by the Bylaws, but not less than three directors and in the absence of such determination shall consist of three directors.

Directors of the Association shall be elected at the annual meeting of the members in the manner determined by the Bylaws. Directors may be removed and vacancies of the board of directors shall be filled in the manner provided in the Bylaws.

ARTICLE VI - OFFICERS

The affairs of the Association shall be administered by the officers elected by the board of directors at its first meeting following the annual meeting of the members of the Association, which officers shall serve at the pleasure of the board of directors.

ARTICLE VII-BYLAWS

The first Bylaws of the Association shall be adopted by the board of directors and may be altered, amended or rescinded in the manner provided by the Bylaws.

ARTICLE VIII - AMENDMENTS

Amendments to the Articles of Incorporation shall be proposed and adopted in the following manner:

Notice of the subject matter of a proposed amendment shall be included in the notice of any meeting at which a proposed amendment is considered.

A resolution approving a proposed amendment may be proposed by either the board of directors or by the members of the Association. Directors and members not present in person or by proxy at the meetings considering the amendment may express their approval in writing, providing such approval is delivered to the secretary at or prior to the meeting.

Approval of an amendment must be by not less than 66-2/3% of the votes of the entire membership of the Association.

No amendments shall make any changes in the qualifications for membership nor the voting rights of members.

A copy of each amendment shall be certified by the Secretary of State and recorded in the Public Records of Bay County, Florida.

ARTICLE IX - RESIDENT AGENT

The Association has named Dana C. Matthews, whose address is 4475 Legendary Drive. Destin, Florida 32541, as its resident agent to accept service of process within the State.
