**ARTICLES OF INCORPORATION
OF
EXPOSING THE TRUTH, INCORPORATED
A Florida "Not for Profit" Corporation**

We, the undersigned, do hereby bind ourselves together for the purpose of forming a not for profit corporation under and pursuant to Florida Statutes Chapter 617, and certify as follows:

ARTICLE I - NAME OF CORPORATION

The name of this corporation shall be Exposing the Truth, Inc., which shall herein be referred to as "TRUTH".

ARTICLE II – PRINCIPAL OFFICE / MAILING ADDRESS

The place in this state where the principal office of the Corporation is to be located is in the City of Fort Lauderdale, Broward County. The mailing address of the Corporation is Post Office Box 1759, Fort Lauderdale, FL 33311-1759.

ARTICLE III – PURPOSE

This corporation is organized exclusively for religious, educational & literary purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. The purpose of TRUTH shall be to address the issues of battered women, school bullying, HIV/Aids and other ostracized issues that are kept a secret because of the shame and embarrassment of the subject matters. These issues often have a negative impact on individuals and families. In fulfilling its' purpose, TRUTH will seek to undertake the following:

1. Write, create and produce theatre performances that focus on a resolution through Christ Jesus to address the above life altering matters. These performances will show resolutions to the problems that negatively affect individuals, their families and their community.
2. Partner with other agencies, organizations and businesses that also focus on battered women, school bullying, HIV/Aids, and etc.

ARTICLE IV - BOARD OF DIRECTORS

The method of selection of the Board of Directors and number of directors shall be as stated in the bylaws.

ARTICLE V - OFFICERS

The officers of TRUTH shall consist of: Pres. – Vernell Robinson, 3791 NW 27 Court, Lauderdale Lakes, FL 33311 and all those other positions set forth in the bylaws with the powers, duties and responsibilities prescribed therein, their qualification, election

and manner of appointment and other matters relating thereto.

ARTICLE VI - REGISTERED AGENT

The name of the registered agent of **TRUTH** is Vernell Robinson. The address of this registered agent is 3791 NW 27 Court, Lauderdale Lakes, Florida 33311.

ARTICLE VII - INCORPORATORS

1. The name and address of the initial incorporator is Vernell Robinson, 3791 NW 27 Court, Lauderdale Lakes, FL 33311.

ARTICLE VIII - MEMBERSHIP

TRUTH shall have no members.

ARTICLE IX - LIMITATIONS

At all times the following shall operate as conditions restricting the operations and activities of **TRUTH**:

Notwithstanding any other provision of these articles, this organization shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal and state income tax under section 501(c)(3) of the Internal Revenue Code or the corresponding provision of any future United States Internal Revenue law; No part of the net earnings of **TRUTH** shall inure to the benefit of, or be distributable to its members, officers, directors, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof; No substantial part of the activities of **TRUTH** shall consist of the carrying on of propaganda or otherwise attempting to influence legislation, or any initiative or referendum before the public, and the corporation shall not participate in, or intervene in (including by publications or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office; and the corporation shall not lend any of its assets to any officer or director of this corporation (unless such loan program is regularly conducted as a part of the activities of **TRUTH** and the qualification of the individual to participate in same is determined by a panel comprised solely of non-Board members), or guarantee to any person the payment of a loan by an officer or director of this corporation.

ARTICLE X - DISSOLUTION

Upon the dissolution of **TRUTH** or the winding up of its affairs, the assets of **TRUTH** remaining after payment of all debts and liabilities shall be distributed to exclusively to one or more religious, educational or literary organizations which would then qualify under the provisions of Section 501(c)(3) of the Internal Revenue Code and its Regulations as they now exist or as they may be hereafter amended. Any such assets not so disposed of shall be disposed of by the Circuit Court of the county in which the principal office of **TRUTH** is then located, exclusively for such purposes or to such organization or organizations as said Court shall determine which are organized and operated exclusively for such purposes.



ARTICLE XI – INDEMNIFICATION

No member, officer or director of **TRUTH** shall be personally liable for the debts or obligations of this corporation of any nature whatsoever, nor shall any of the property of the members, officers or directors be subject to the payment of the debts or obligations of this Corporation. Any person (and the heirs, executors and administrators of such person) made or threatened to be made a party to any action, suit or proceeding by reason of the fact that he/she is or was a director or officer of **TRUTH** shall be indemnified by **TRUTH** against any and all liability and the reasonable expenses, including attorney's fees and disbursements, incurred by him/her (or by his/hers heirs, executors or administrators) in connection with the defense or settlement of such action, suit or proceeding, or in connection with any appearance therein, except in relation to matters as to which it shall be adjudged in such action, suit or proceeding that such director or officer is liable for negligence or misconduct in the performance of his duties. Such right of indemnification shall not be deemed exclusive of any other rights to which such director or officer (or such heirs, executors or administrators) may be entitled apart from this Article.
