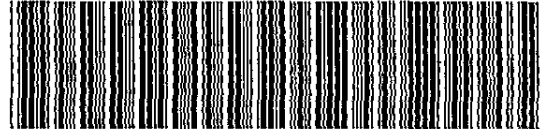

Articles of Incorporation

A NON-PROFIT CORPORATION

The undersigned incorporators, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt the following Articles of Incorporation:

Article I

The name of this corporation is: Iglesia Cristiana Llevando Una Luz, Inc.

Article II

The principal place of business and mailing address for this corporation shall be:
271 NE Airoso Blvd. Port St. Lucie, Florida 34983

Article III

The specific purposes for which this corporation is organized are:

1. Offer advancement of religion, relief the poor distressed and underprivileged families in the community, and provide services to senior citizens.
2. This corporation is organized exclusively for one or more of the purposes as specified in Section 501 (c) (3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code.
3. The purpose of the corporation is to engage in any lawful act or activity for which corporations may be organized under the Florida Laws.

Article IV

The number of initial directors this corporation shall have and the names and addresses of the initial directors are as follows:

This corporation shall have (four) directors.

1. Dolly J. Rodriguez - 271 NE Airoso Blvd. Port St. Lucie, Florida 34983.
2. Misael Rodriguez - 271 NE Airoso Blvd. Port St. Lucie, Florida 34983.
3. Ana Maria Balmaseda - 502 SW 13 Avenue, Apt. 2, Miami Florida 33135.
4. Luisa Marie Alvarez - 457 SW Bill Traitel Avenue, Port St. Lucie, Florida 34953.

Article V

The manner in which the directors are elected or appointed is:

- The Directors term of office will be three years on a staggered term basis.

Each Director may hold office at any time, and may hold office until he or she resigns, or is removed by majority of other directors votes, or is other wise disqualified to serve, or until his or her successor shall be elected and qualified, which ever occurs first. The initial directors shall be selected according to ByLaws from among distinguished members of the community. At the end of each term, directors will be elected according to ByLaws.

Article VI

Term of Existence for this corporation:

This corporation is to exist perpetually.

Article VII

Registered Agent:

Article VIII

Article IV

Additional Provisions for the operations of the corporation are as follows:

1. Upon the dissolution of this corporation, its assets remaining after payment, or provisions for payment, of all debts and liabilities of this corporation shall be distributed for one or more exempt purposes within the meaning of the Section 501 (c) (3) of the Internal Revenue Code or shall be distributed to the federal government, or to a state or local government, for a public purpose.
2. No substantial part of the activities of this corporation shall consist of carrying in propaganda, or otherwise attempting to influence legislation (except as otherwise provided by Section 501 (h) of the Internal Revenue Code), and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.
3. No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to, its members, directors, officers or other private persons, except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these Articles.
4. Notwithstanding any other provisions of these Articles, this corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Sections 501 (c) (3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code.
