FIRST ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF CAMDEN FIELD HOMEOWNERS ASSOCIATION, INC.

Pursuant to the provisions of Sections 617.1001, 617.1002 and 617.1006 of the Florida Statutes, CAMDEN FIELD HOMEOWNERS ASSOCIATION, INC., a Florida not for profit corporation (the "Corporation") adopts the following First Articles of Amendment to its Articles of Incorporation.

ARTICLE I

NAME

The name of the corporation is **CAMDEN FIELD HOMEOWNERS ASSOCIATION, INC.** The Articles of Incorporation were filed with the Florida Secretary of State on October 10, 2005.

ARTICLE II

AMENDMENT

Article I of the Articles of Incorporation of this corporation is hereby amended for the purposes of changing the name of the corporation by deleting the existing Article I in its entirety, and substituting the following therefore to wit:

"ARTICLE I NAME

The name of the corporation shall be "CAMDEN WOODS HOMEOWNERS ASSOCIATION, INC."
