### ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF

SPYGLASS OFFICE PARK CONDOMINIUM ASSOCIATION, INC. DOCUMENT NUMBER: N05000010481

ROILES SERVES LATE Pursuant to the provisions of §617.006, Florida Statutes, this Florida Not-For-Profit Corporation adopts the following amendments to its Articles of Incorporation:

Section II. PURPOSE shall be amended to include the following two paragraphs:

- 2.2 The Association shall operate, maintain and manage the surfact water or stormwater management system in a manner consistent with the St. Johns River Water Management District permit number 82228-2 requirements and applicable District rules, and shall assist in the enforcement of the Declaration of Condominium which relate to the surface water or stormwater management system.
- 2.3 The Association shall levy and collect adequate assessments against members of the Association for the costs or maintenance and operation of the surface water or stormwater management system.

Section XII. TERM shall be amended in its entirety with the following paragraph:

Existence of the Association shall commence with the filing of the original Articles of Incorporation with the Secretary of State, Tallahassee, Florida. The Association shall exist in perpetuity.

These Articles of Incorporation shall be amended to include a new Section XIV. **DISSOLUTION** as follows:

### XIV. DISSOLUTION

In the event of Termination, dissolution or final liquidation of the Association, the responsibility for the operation and maintenance of the surface water or stormwater management system must be transferred to and accepted by an entity which would comply with Section 40C-42.027, F.A.C., and be approved by the St. Johns River Water Management District prior to such termination, dissolution or liquidation.

The date of adoption of the amendments was August 2009.

There are no members or members witled to vote on the amendments. These amendments were adopted by the board of directors.


