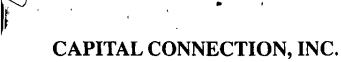

AMENDMENT TO THE ARTICLES OF INCORPORATION OF BOYNTON BEACH ORTHODOX ASSOCIATION, INC.

ARTICLE I NAME

The name of the corporation shall be:

Boynton Beach Orthodox Association, Inc.

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

We are organizing for the purpose of forming a Synagogue so that we may worship according to our tradition within our community. We are a community of Orthodox Jews committed to prayer, study and social interaction. We engage in there to further our spiritual growth, both individually and as a community.

Said organization is organized exclusively for charitable, religious and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

ARTICLE IV DISSOLUTION
