Then upon 7 day posting of such meeting will the previous and or present directors be able to vote on adding or omitting any elected directors. There may be objections from the floor in which the governing body of directors will take into account. Upon nomination from the floor will a vote be taken to decide whom will be elected. There will be a minimum of two with a maximum of seven directors at any one time. This can be changed by a vote from the present board to change the standing articles of incorporation. Then to be submitted for official change.
