The incorporators of jazzybluedance, inc. hereby adopt the following articles, pursuant to Chapter 617.0202 of Florida Statutes:

Article I: The name of the corporation shall be: jazzybluedance, inc.

Article II: The principal place of business and mailing address of this corporation shall be: 410 Fir Avenue Niceville, FL 32578

Article III: jazzybluedance, inc. is organized to provide arts education and appreciation experiences and opportunities for children and adults.

We will provide studio dance, music, movement and spoken word training and education, with on-site and off-site presentations for community, school and other events and organizations. Workshops and seminars will be organized and presented, designed to expand awareness, appreciation and participation in the arts.

Our goal is to provide arts education and experience to reach the widest and most diverse population throughout the local community, region and state of Florida.

This corporation is organized exclusively for charitable, literary and educational purposes to bring the benefits of the arts to the public, including for such purposes, the making of distributions to organizations that qualify under section 501(c)(3) of the Internal Revenue Code, or any corresponding section of any future federal tax code.

No proceeds of the corporation will enrich any individual, except that reasonable compensation may be paid for services to the corporation. If the corporation is dissolved, any assets remaining will be distributed to another corporation serving similar purposes and qualifying as a tax-exempt, charitable organization under the provisions of 501(c)(3) of the Internal Revenue Code.

Article IV: Members of the board of directors for jazzybluedance, inc will be elected, as detailed by our corporate by-laws. Their primary governance responsibility is fiduciary, i.e., to uphold the public trust and ensure public benefit from this corporation.

Board members will not receive compensation or personal benefit for their membership on the board of directors.


