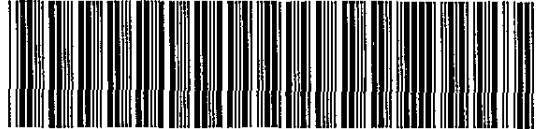

**ARTICLES OF INCORPORATION OF
C.P.Q. INTERNATIONAL HANDBALL ASSOCIATION, INC.**

The undersigned incorporator for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation.

**Article I
NAME**

The name of the Not for Profit Corporation being formed shall be that of **C.P.Q. INTERNATIONAL HANDBALL ASSOCIATION, INC.**

**Article II
PRINCIPAL OFFICE**

**Article III
PURPOSES**

The specific purposes for which this Not for Profit Corporation is organized is to maintain, promote, sustain and develop the interest at the national, state and local levels in the teaching and the learning by the greatest number of people of the sport of **HANDBALL**, one of the most effective and complete forms of exercise of the human body. To that effect the corporation shall prepare brochures, videos, pamphlets, and other media to create the conditions necessary to commence the actual teaching of the sport by qualified instructors who shall bring demonstrations to schools, service clubs, fraternal institutions, and religious organizations providing thereby the widest publicity to the sport of handball. Further, the Corporation is interested in attracting and involving in its main activity of teaching the sport to the less fortunate, specially the children of the homeless and to provide them with an incentive that may perhaps in some form alleviate and improve their station in life.
