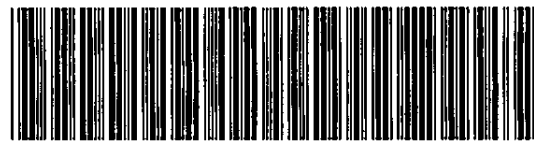



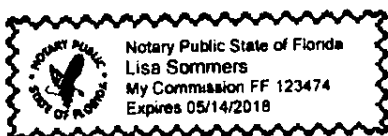

**Amendment No. 1 to Article VI, Section 2 of the Articles of Incorporation**

ARTICLE VI  
Directors

1. The business of this Association shall be conducted by a Board of Directors having three (3) Directors.

2. The election of Directors, their removal or the filling of vacancies on the Board of Directors shall be in accordance with the Bylaws of the Association. ~~Directors shall be elected at the annual meeting of the members of the Association by the Developer (if applicable) and by the members, and they shall hold office for one (1) year term or until their successors are duly elected. The Developer shall have the right to elect a majority of the Directors until such time as it is required by law to transfer control of the Association to unit owners.~~
