The undersigned subscriber to these Articles of Incorporation hereby subscribes to and forms a corporation not-for-profit under the laws of the State of Florida.

ARTICLE I NAME

The name of this corporation is LADY HURRICANES, INC.

ARTICLE II INITIAL PRINCIPAL OFFICE AND REGISTERED AGENT

The address of the initial principal office of the corporation in the State of Florida is 219 Sherman Avenue, Panama City, Florida 32401, and the name of the initial registered agent is Michelle Mathes, whose address is 219 Sherman Avenue, Panama City, Florida 32401.

ARTICLE III PURPOSE
