

Article of Incorporation of the undersigned, being all of the directors of the corporation, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Florida Statutes §617.017 and §617.0201 regarding a corporation not for profit under Florida Statutes §617.01 et. seq. and hereby adopt the following Articles of Incorporation:

#### ARTICLE ONE

The name of the not for profit Corporation shall be GARRET MOSS S.T.O.K.E.D. FOUNDATION INC. (STARTING TEENS OVER KEEPING EVERYTHING DRUG FREE FOUNDATION), hereinafter referred to as "S.T.O.K.E.D." or "the Foundation." The corporation's principal office and mailing address is 419 Red Hawk Drive, Jupiter, Florida 33477.

#### ARTICLE TWO

The purposes for which the corporation is formed are:

- 1) To help teens and others be drug free;
- 2) To mentor teens and others;
- 3) To assist teens with drug problems to start over;
- 4) To collect and otherwise raise money for the purposes stated herein;
- 5) To cooperate with federal, state and local government agencies to achieve the purposes stated herein;
- To do everything lawful, necessary, suitable and proper to attain the charitable purposes set forth herein; and
- 7) Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

#### ARTICLE THREE

The conditions and regulations of membership, and the rights and privileges of the classes of membership shall be determined and fixed by the bylaws.

#### **ARTICLE FOUR**

The term of existence of this corporation is perpetual.

## **ARTICLE EIGHT**

#### **ARTICLE NINE**

The bylaws of the corporation are to be made, altered or rescinded by the Board of Directors.

#### ARTICLE TEN

These Articles of Incorporation may be amended by the Board of Directors of the Corporation. Such amendments may be proposed and adopted as provided in the bylaws of the corporation.

#### ARTICLE ELEVEN

The private property of members of the corporation shall not be liable for corporate debts.

#### **ARTICLE TWELVE**

- No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to, any director or office of the corporation or any member of the corporation or any other private individual (except that reasonable compensation may be paid for services rendered to or for the corporation affecting one or more of its purposes) and no director or office of the corporation, or any private individual shall be entitled to share in the distribution of any of the corporate assets or dissolution of the corporation. Upon dissolution of the corporation any remaining assets after payment of outstanding liabilities shall be contributed to any one or more 501(c)(3) qualifying tax exempt organizations.
- 2) No substantial part of the activities of the corporation shall be carrying on of propaganda, or otherwise attempting to influence

legislation, and the corporation shall not participate in, or intervene in any political campaign on behalf of any candidate for public office.

3) Notwithstanding any other provision of these Articles of Incorporation, the corporation shall not conduct or carry on any activities not permitted to be conducted or carried on by any organization exempt from taxation under Florida Statutes and Section 501(c)(3) of the Internal Revenue Code of 1954 and Regulations issued pursuant thereto as they now exist or as they may hereafter be amended.

#### **ARTICLE THIRTEEN**

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
