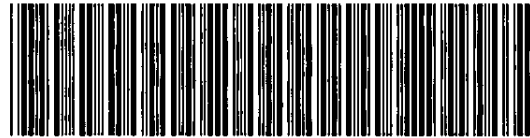



**EXHIBIT A**  
**SCHEDULE OF AMENDMENTS**  
**TO THE**  
**ARTICLES OF INCORPORATION**  
**FOR**  
**LA VISTANA CONDOMINIUM ASSOCIATION, INC.**

1. Article 2 of the Articles of Incorporation is amended to read as follows:

*The purpose for which the Association is organized is to ~~provided~~ provide an entity pursuant to the Florida Condominium Act as it exists on the dates hereof (the "Act") for the operation of ~~that~~ those certain condominiums located in Pinellas County, Florida, and known as LA VISTANA, a Condominium and LA VISTANA B, a Condominium (the Condominium).*

2. Article 4, Provision (b) of the Articles of Incorporation is amended to read as follows:

*(b) To exercise all of the powers and privileges and to perform all of the duties and obligations of the Association as set forth in that certain Declaration of Condominium of LA VISTANA, a Condominium, and that certain Declaration of Condominium of LA VISTANA B, a Condominium, hereinafter called the "Declaration", applicable to the property and recorded or to be recorded in the Public Records of Pinellas, Florida and as the same may be amended from time to time as therein provided, said Declaration being incorporated herein as if set forth at length;*

3. Article 4, Provision (q) of the Articles of Incorporation is amended to read as follows:

*(q) To operate as a multicondominium consisting of two condominiums.*
