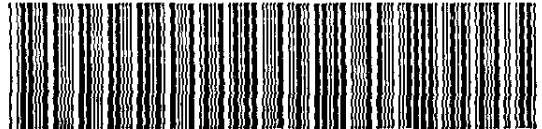

**ARTICLES OF INCORPORATION
OF THE FLORIDA MARINE CONTRACTORS PAC (Political Action
Committee), INC.**

The name of this committee shall be Florida Marine Contractors PAC, Inc., a Political Action Committee (Section 106.04 Florida Statutes).

**ARTICLE II
PURPOSE**

Florida Marine Contractors PAC, Inc., is a Political Action Committee established to further the goal of sound and stable economic growth and to promote the improvement of state government in Florida. Funds will be solicited by this committee and used to recommend the election of candidates for political office. These candidates will have demonstrated their commitment to the principals of the free enterprise system and more specifically Florida's marine construction industry. The committee will actively encourage qualified and interested citizens to seek political office and become more involved in the governmental affairs of Florida. Contributions and encouragement will be made without regard to political party affiliation. This committee is an independent, autonomous entity not affiliated in any way with particular political parties.

**ARTICLE III
REGULATION AND OPERATION**

The regulation and operation of the business affairs of the Florida Marine Contractors PAC, Inc., shall be determined by this constitution and By-Laws and such rules as may be adopted by the Board of Directors. The Board of Directors shall be the same as those individuals elected to office for Florida Marine Contractors PAC, Inc.,

**ARTICLE V
MEMBERSHIP, DUES AND CONTRIBUTIONS**

SECTION 1. MEMBERSHIP – Membership in the Committee shall be open to any person or firm engaged in the marine construction industry or any person or firm affiliated with this industry. A contribution to Florida Marine Contractors PAC, Inc., constitutes an application for membership to the committee.

Applications will be automatically accepted 30 days following receipt of the contribution unless otherwise determined by the Board of Directors.

If for any reason application is refused, applicant will be notified by mail and the contribution shall be returned.

Florida Marine Contractors PAC, Inc., is authorized to establish additional categories of membership.

ARTICLE VI **BOARD OF DIRECTORS**

SECTION 1. MANAGEMENT – The management of the Committee shall be vested in the Board of Directors who will annually appoint a slate of Officers consisting of a Chairperson and Secretary-Treasurer.

SECTION 2. RESIGNATION – Any officer or member of the Board of Directors may resign at any time by written notice to the Chairperson. Resignation of the Chairperson shall be given in writing to the Secretary-Treasurer.

SECTION 3. VACANCY – Any vacancy in the membership of the Board of Directors may be filled by election of the remaining Board of Directors and this new member shall serve until the next regular annual meeting.

SECTION 4. BOARD OF DIRECTORS – The Directors shall be selected annually. The Chairperson will prepare a single slate to be submitted to the committee membership. Directors shall be considered automatically elected 10 days after the mailing if there are no "write in" candidates.

SECTION 5 EMPLOYEES – The Board of Directors may employ personnel necessary to carry out the purpose of the committee.

SECTION 6 DIRECTOR OF VOTING – The Directors may act by mail, email, or telephone with majority consent of the Board of Directors. Majority vote of the Directors will be required for any proposed action at a called meeting.

SECTION 7 SECRETARY – The Secretary shall perform the administrative functions for the Board of Directors.

SECTION 8 TREASURER – The Treasurer shall be the custodian of the funds of Florida Marine Contractors PAC, Inc. He shall collect all necessary other funds of the organization. He shall disburse all monies Florida Marine Contractors PAC, Inc., in accordance with the instructions of the Board of Directors.

ARTICLE VII
MEETINGS

There shall be at least one general membership meeting held each year. The Chairman shall decide upon time and place of meeting. Notices of the General Membership meeting must be in writing and postmarked fourteen (14) days prior to the meeting date.

ARTICLE VIII
AMENDMENTS

This Constitution and By-Laws may be amended by a majority vote of the members present at the duly called meeting.

ARTICLE IX
DISSOLUTION

Upon dissolution of the Committee, all of its assets, after expenses and debts have been paid, shall be distributed and returned to the members on a prorated basis of contributions or as shall be decided by majority vote of the Board of Directors.


