## ARTICLES OF INCORPORATION

### **Article I: Name**

The name of the Corporation shall be United Families of Faith, Inc.

### **Article II: Principal Office**

The principal office of the Corporation is to be located at 3333 Avenue I, Riviera Beach, Florida 33404.

### **Article III: Purpose**

Said corporation is organized exclusively for charitable, religious, and educational purposes including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

United Families of Faith, Inc. is a nondenominational, faith-based organization focusing on outreach and support to families, youth and individuals. Our mission is to help empower people to live balanced and healthier lives spiritually, physically, emotionally, socially and financially. We do this through prevention, intervention and treatment programs and supports in the life domains of behavioral health (substance abuse and mental health), physical health, rehabilitation, residential, economic sufficiency, recreation, education and training, criminal/juvenile justice and other programmatic services. Our desire is to share the good news of Jesus Christ and His saving grace throughout the world.

### **Article IV: Manner of Election**

The Incorporator shall select the initial slate of Directors and Officers; thereafter Directors shall be elected according to the by-laws of the corporation.

### **Article V: Initial Board of Directors**

The names and addresses of the persons who are the initial trustees of the corporation are as follows:

### **Article VI: Limitations**

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

**Article VII: Dissolution**

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, or to a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

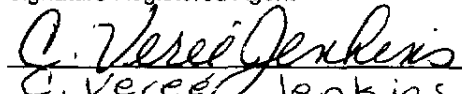
