ARTICLE 1 NAME

The name of the corporation shall be: SUNRISE SCHOOL OF MIAMI, INC.

ARTICLE 2 PRINCIPAL PLACE OF BUSINESS

The principal place of business of this corporation shall be 8795 SW 112 Street, Miami, Florida 33176 and its mailing address shall be 15307 SW 141st Street, Miami, Fl 33196.

ARTICLE III PURPOSE

The purpose for which the corporation is organized is to provide charitable and educational services within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law which replaces the same. The corporation will act in a completely nondiscriminatory manner, regardless of the basis of race, religion, color, sex, national origin, marital status, sexual orientation, age, physical or mental disability, or status as a disabled veteran or veteran of the Vietnam Era.

ARTICLE VIII AMENDMENTS

These Articles of Incorporation may be amended by a majority vote of the Board of Directors.

ARTICLE IX NEGATION OF PECUNIARY GAIN

This corporation is not organized for pecuniary gain or profit. It shall not have any power is issue Certificates of Stock or declare any dividends. No part of the net earnings shall inure to the benefit of, or be distributed to, any member, director, officer or other private persons; provided, however, that this shall not be construed to prohibit payment by the corporation of reasonable compensation for services rendered or to prohibit payments and distributions by the corporation in furtherance of its purposes as described in Article III hereof.

ARTICLE X PROHIBITED ACTIVITIES

No substantial part of the activities of the corporation shall be for the purpose of carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not be permitted in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry out any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding sections of any future tax code applicable to it.

ARTICLE XI

Upon dissolution of the corporation in accordance with Florida law, the Board of Directors shall, after payment of or making provision for the payment of all liabilities of this corporation, distribute the remaining assets of the corporation to one or more other entities which are exempt under section 501(c)(3) or in another fashion permitted under the then applicable Internal Revenue Code. Any assets not disposed of by the

corporation shall be disposed of by order of the Miami-Dade Circuit Court having jurisdiction of the dissolution.
