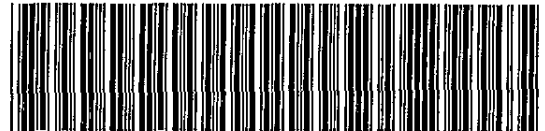

ARTICLES OF INCORPORATION

SECRETARY OF STATE

Pursuant to Chapter 617.0202, F.S., the articles of incorporation of the undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Florida, do hereby certify:

Article I: The name of the corporation is Make Us One Ministries, Inc.

Article II: The principle place of business in the city of Jacksonville, Duval County, Florida:

Article III: Purpose Clause:

Make Us On Ministries, Inc. is a Christian teaching ministry organized exclusively for religious, charitable purposes, including, for such purposes, the receiving of deductible contributions under section 170(b)(1)(A)(i) of the Internal Revenue Code and giving of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or to the corresponding section of any future federal tax code.

The mission and purpose of Make Us One Ministries, Inc. is to teach the Gospel of Jesus Christ according to the King James Version of the Holy Bible.

The vision of Make Us One Ministries, Inc. is to develop mature Christians who are willing to learn the Word of God and to live the Word of God for the purpose of unity in the Body of Christ so that people will believe in Jesus because of our example.

Article IV: Election or Appointment of Officers and/or Directors:

The method of election or appointment of Officers and/or Directors is as stated in the bylaws.

Article VI: Limitations:

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. As outlined in this said article, this corporation shall not engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

Article VII: Dissolution Clause:

Upon dissolution of the corporation, assets shall be distributed to the local government of Jacksonville, Florida for a public purpose. The initial preferred public purpose is for said assets to be distributed to the American Red Cross. Any such assets not so distributed, shall be disposed of by a Court of Competent Jurisdiction of Duval County Florida to such organization(s) as said Court shall determine, which are organized and operated exclusively for such purposes.




