# ARTICLES OF INCORPORATION

of

# ARTICLE I NAME:

The name of the corporation shall be: Final Call Ministry International, Inc.

# ARTICLE II PRINCIPAL OFFICE:

The principle office of the corporation will be: 409 N. Hernandez Ct. Tampa, FL 33603

### ARTICLE III PURPOSE:

### The purpose for which the corporation is formed is as follows:

- (a) To disseminate the Gospel of Jesus Christ and the Word of God, to the end that people may be evangelized and believers may be conformed to the image of Jesus Christ, to regularly assemble for fellowship to worship God inSpirit and in Truth and to cooperate in the building up of the whole body of Christ.
