Florida Statutes, this Florida Not For Profit Corporation
adopts the following Amended and Restated Articles of
Incorporation:

AMENDED AND RESTATED
ARTICLES OF INCORPORATION
of
SEFFNER MANGO VOLUNTEER FIRE RESCUE, INC.

ARTICLE I NAME

The name of the corporation shall be Seffner Mango
Volunteer Fire Rescue, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of
this corporation shall be 208 Claire Drive, Seffner,
Florida, 33584.

ARTICLE III PURPOSE

The corporation is organized exclusively for
charitable, educational, and scientific purposes,
including, for such purposes, the provision of facilities
and services within a designated fire district for
protection of the public in case of fire or medical
emergencies and in aid of civil defense.

ARTICLE IV MANNER OF ELECTION OF DIRECTORS

The Board of Directors shall consist of not fewer than
five nor more than fifteen members, but must be an odd
number. Directors shall be elected by the Board of
Directors, and shall serve until removed or resigned. The

C. Participate to any extent in any political campaign for or against any candidate for public office; or

D. Conduct any activities not permitted to be carried on by organizations exempt under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, and its regulations as they now exist or as they may hereafter be amended.

ARTICLE VI DISSOLUTION

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code,


