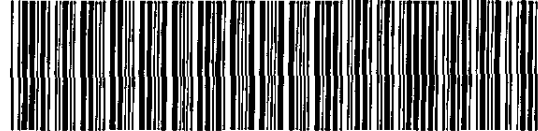

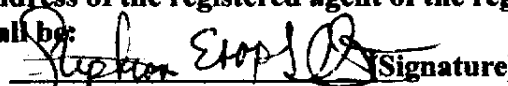

ONE: The name and address of this principal corporation is At The Radius Group, Inc. 2258 NW 63rd Street Miami, Florida 33147, in Miami-Dade County. The corporation is organized pursuant to the FLORIDA Nonprofit Corporation Code.

TWO: This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. The corporation is organized under the Nonprofit Public Benefit Corporation Law for, Educational and Charitable purposes to aid the poor and disadvantaged youth and families towards a life of self-sufficiency. To establish structured support service for outreach to the community. The programs will consist of but shall not be limited to: Mentoring, Tutoring, Summer Camp Activities, and other programs to aid those who are in need.

THREE: The duration of this corporation shall be perpetual, no stock and shall have no members.

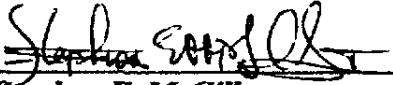
SIX: The Directors are elected in accordance with the Bylaws. The name and address of the persons appointed to act as the initial Directors of this corporation are:
