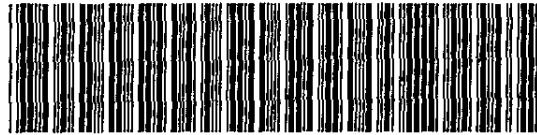



NAME**


