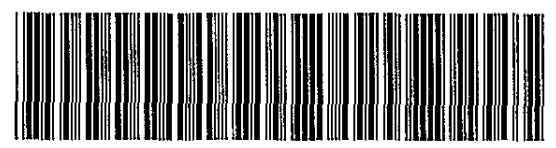

Pursuant to the provisions of section 617.1006, Florida Statutes, this *Florida Not For Profit Corporation* adopts the following amendment(s) to its Articles of Incorporation:

Article III - a. Octavio Feline Foundation, Corp. is organized exclusively for a charitable purpose under Section 501 (c) 3 of the Internal

Revenue Service Code to spay & neuter cats/kittens in our community in an effort to reduce the pet overpopulation, to provide

the necessary medical care to abandoned, injured or abused cats/kittens, bring them back to health and put them in our adoption program,

to provide medical care, food and litter to low-income cat lovers in our community.

b- No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees,

officers, or other private person except to pay our participants veterinarians for medical care and/or surgeries of rescued cats/kittens.

This organization will not participate in any political campaigns nor will influence legislation. This organization will not engage in other

activities than the ones mentioned above to rescue/help cats and kittens.

c. Upon dissolution of the organization, assets will be distributed for one or more exempt purposes within the meaning

of the section 501 (c) 3 of the Internal Revenue Service Code, or corresponding section of any future federal tax code, or will be

distribute to the federal government or to a state or local government. Any other assets will be used to pay any remaining

balance to veterinarians for services provided to the rescued cats and kittens.


