ARTICLES OF INCORPORATION OF UNIVERSITY MEDICAL CAMPUS ASSOCIATION, INC.

The undersigned, by these Articles associate themselves for the purpose of forming corporation not for profit under Chapter 617, Florida Statutes, and certify as follows:

ARTICLE L NAME

The name of the corporation shall be UNIVERSITY MEDICAL CAMPUS CONDOMINIUM ASSOCIATION, INC.

ARTICLE II. DURATION AND COMMENCEMENT OF EXISTENCE

The corporation is to have perpetual existence, commencing at the filing of these articles with the Department of State.
