


The Articles of Incorporation of Melek International, Inc.

Articles of Incorporation of the undersigned, whom are citizens of the United States, destring to form a Nonprofit Corporation under the Non-profit Corporation Law of Chapter 617, Florida Statues, do hereby certify:

Article Two: The place in this state where the principal office of the Corporation is to be located is 831 Camargo Way #107 Altamonte Springs, FL 32714
