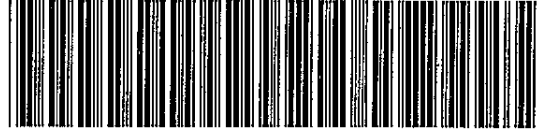

The Articles of Incorporation of Melek International, Inc.

Articles of Incorporation of the undersigned, whom are citizens of the United States, desiring to form a Nonprofit Corporation under the Non-profit Corporation Law of Chapter 617, Florida Statutes, do hereby certify:

Article One: The name of the Corporation shall be **Melek International, Inc.**

Article Two: The place in this state where the principal office of the Corporation is to be located is 831 Camargo Way #107 Altamonte Springs, FL 32714

Article Three: The purpose of this corporation will be to enrich, improve and enhance at-risk marriages and families spiritually, mentally, physically, emotional and socially through biblical principles. Secondly, we will enhance the moral and economic vitality of our community and around the world through conferences, seminars, workshops, consulting and advisory services.
