TO

NOTICE IS HEREBY GIVEN that pursuant to Section 617.1002, Fla. Stat., and Article 13 of the Articles of Incorporation for Crosswynde Condominium Association, Inc., at a duly called and properly noticed meeting of the members held on September 3, 2014, by an affirmative vote of at least a majority of the votes which members present at such meeting or represented by proxy were entitled to cast, Article 10, Section 10.1 of the Articles of Incorporation for Crosswynde Condominium Association, Inc., was, and the same is hereby amended as follows:

10.1 Number and Qualification. The property, business and affairs of the Association shall be managed by a board consisting of the number of directors determined in the manner provided by the By-Laws, but which shall consist of not less than three (3) and not more than ~~five (5)~~ seven (7) directors. Directors need not be members of the Association.
