

ADOPTED ARTICLE OF AMENDMENTS TO THE ARTICLES OF INCORPORATION OF THE RESERVE AT MEADOW OAKS PROPERTY OWNER'S ASSOCIATION, INC.

1. Adopted amendment to ARTICLE V of the Articles of Incorporation of The Reserve at Meadow Oaks Property Owner's Association, Inc. (the "Articles"), to read as follows:
