ARTICLES OF INCORPORATION



Article I

The name of this Corporation is ECCLESIA CHRISTI, INC. (hereinafter called the "Corporation").

Article II

The address of the principal office and the mailing address of the Corporation shall be 200 NE 14th Avenue, #15, Fort Lauderdale, Florida 33301.

Article III

The Corporation is organized and operating as a church, exclusively for religious, educational, and charitable purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 50l(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article IV

Directors are elected by majority vote of registered members of the Corporation (church).

Article V

The Directors are:

- 1. Karen Unger, Director, 912 Ponce de Leon Drive, Fort Lauderdale, FL 33316
- 2. Linda Milark, Director, 813 SE 14th Court, Fort Lauderdale, FL 33316
- 3. Thomas Chamberlain, Director, 200 NE 14thAvenue, #15, Fort Lauderdale FL 33301

Article VI

The Corporation's initial registered agent and street address in the State of Florida is Thomas Lynn Chamberlain, 200 NE 14th Avenue, #15, Fort Lauderdale, Florida 33301.

Article VII

The name and address of the sole incorporator is Thomas Lynn Chamberlain, 200 NE 15th Avenue, #15, Fort Lauderdale, Florida, 33301.

Article VIII

Upon the dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations as said Court shall determine, which are organized and operated exclusively for such purposes.

Article IX

No part of the net earnings of the Corporation share inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these Articles of Incorporation, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

IN WITNESS WHEREOF, the undersigned, being the Incorporator for the purpose of forming a Corporation pursuant to the Florida Not For Profit Corporation Act, Chapter 617, Florida Statutes, as amended, has signed these Articles of Incorporation this 20th day of October, 2005.
