ARTICLES OF INCORPORATION

The undersigned acting as incorporators(s) to a corporation pursuant to Chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:

ARTICLE I - CORPORATE NAME

The name of the corporation shall be:

ARTICLE III – PURPOSE

The said organization shall be organized and operated exclusively religious, charitable, cultural, educational and scientific purposes, including for such purposes the making of distributions to organizations that qualify as exempt organizations under section 501 © (3) of the Internal Revenue Code. The organization is formed to engage in any and all lawful activities incidental to the foregoing purposes, except as restricted herein. All organization properties shall be irrevocably dedicated to the charitable purposes described in these articles. The net earnings of the organization will never be permitted to benefit of or be distributable to its board, officers or other private individuals to any extent except that the organization be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these articles. No substantial part of the organization's activities will ever consist of providing insurance to a type similar to that provided commercially or of carrying on propaganda or attempting to influence legislation or other aspects of the political process. The organization will not take part or intervene in any political campaign.

ARTICLES IV - MANNER OF ELECTION

Directors shall be elected by a majority vote.

ARTICLE V - INITIAL DIRECTORS AND/OR OFFICERS

ARTICLE VIII - AMENDMENT OF ARTICLES

No amendment may authorize any purpose or activity that is in conflict with section 501 © (3) of the Internal Revenue Code.

ARTICLE IX - DISSOLUTION

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 © (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
