ARTICLES OF INCORPORATION | LED

MISSIONWAY COMMUNITY CHURCH, ENC NOV 10 P 4: 33 OF JACKSONVILLE, FLORIDA TALLAHASSEE, EL ORIOA

We, the undersigned individuals, hereby subscribe to the following Articles of Incorporation for the purpose of forming a non-profit corporation pursuant to Chapter 617, Florida Statutes (F.S.).

ARTICLE I. NAME

The name of the corporation shall be: MissionWay Community Church, Inc.

ARTICLE II. PRINCIPAL OFFICE

The principal mailing address of MissionWay Community Church, Inc. shall be:

Mission Way Community Church Ronald V. Henson, Pastor P. O. Box 600383 Jacksonville, FL 32260

The Church shall have full power and authority to change the principal office from one location to another. Any change of this location shall be recorded by the Secretary and this section may be amended to state the new location.

ARTICLE III. PURPOSE

The purpose for which the corporation is formed is to operate as a church, exclusively for religious purposes in such a manner that the corporation shall qualify as an exempt organization under Section 501(c)(3) of the Internal Revenue Code, and to have and exercise all rights and powers conferred on a non-profit corporation under the laws of the State of Florida.

The emerging vision (purpose) of MissionWay Community Church, Inc. is to be a mission-focused church that speaks the language of the modern culture and encourages non-believers to investigate Christianity in a safe environment and at their own pace.

ARTICLE IV. AFFILIATION

MissionWay Community Church, Inc. is an autonomous church and maintains the right to govern its own affairs, independent of any denominational control. Recognizing, however, the benefits of cooperation with other churches in world missions, MissionWay Community Church, Inc. voluntarily affiliates with the Southern Baptist Convention in its national, state and local expressions.

ARTICLE V. CHURCH OFFICERS

Section I.

A. The officers of MissionWay Community Church, Inc. will consist of a minimum of five (5) persons. The actual number of officers will be determined by the Leadership Team during its meetings.

Section II.

- A. The Pastor of MissionWay Community Church, Inc. will serve as President of the Corporation and will be the moderator of the church. In his absence, another member of the Leadership Team, as designated by the Pastor, will serve as moderator.
- B. A member of the Leadership Team, designated by the Pastor, will serve as Vice President of the Corporation.
- C. A member of the Leadership Team, designated by the Pastor, will serve as Financial Manager and Secretary/Treasurer of the Corporation.
- D. The remaining officers of MissionWay Community Church, Inc. will be nominated by the Leadership Team. Each officer will be an active member of the Church.

Section III.

A. The officers of MissionWay Community Church, Inc. are hereby designated as the Directors of the Church, and thereby Directors of the Corporation.

Section IV.

A. It shall be the duty of the officers to act as legal representatives of the Church and to take such actions and execute any documents necessary to accomplish the purpose of any matter authorized by the members of MissionWay Community Church, Inc. which concern any real or personal property of the Church.

ARTICLE VI DISSOLUTION

If MissionWay Community Church, Inc. should ever dissolve, upon the dissolution of the 4: 33 corporation, assets shall be distributed to one or more exempt religious or gantzations or purposes within the meaning of section 501(c)(3) of the Internal Revenue Code; ALLAHASSEE, FLORIDA
