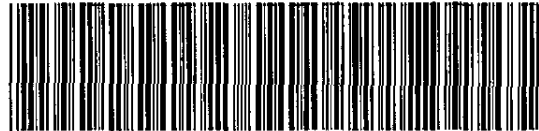

ARTICLES OF INCORPORATION
OF

EGLISE DU CHRIST RESSUSCITE, INC.

ARTICLE I - DURATION

The name of this corporation shall be: Eglise du Christ Ressuscite, Inc..

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE

The corporation is a not for profit corporation, organized specifically and primarily to solicit, collect, accumulate, administer, receive and maintain real and personal property, or both, in whatever form, including cash funds from public and private sources, and, subject to the restrictions and limitations hereinafter set forth: to use and apply the whole or any part of the income there from, and the principal thereof, exclusively for religious, charitable, or religious education purposes either directly or by contributions to organizations that qualify as exempt organizations under section 501 (c)(3) of the Internal Revenue code and the regulations issued pursuant thereto as they now exist or as they may here after be amended.

- (a) the general purpose for which this corporation is formed is to operate exclusively for such religious, charitable and education purposes as will qualify it as an exempt organization under section 501 (c) (3) of the Internal Revenue Code of 1986 or corresponding provisions of any subsequent federal tax.

- (b) this Corporation shall not, as a substantial parts of its activities, carry on propaganda or otherwise attempt to influence legislation; nor shall it participate or intervene by publication or distribution of any statements or otherwise, in any political campaign on behalf of any candidate for public office.

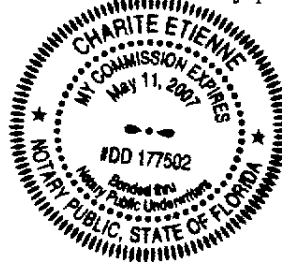
