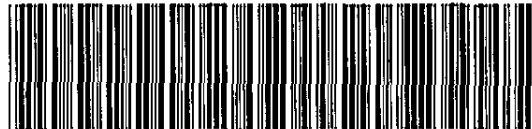

**ARTICLES OF INCORPORATION - FOR A NONPROFIT CORPORATION**

Executed by the undersigned for the purpose of forming a Florida corporation under Chapter 617 of the Florida Statutes **WITHOUT STOCK AND NOT FOR PROFIT.**

**ARTICLE I - CORPORATE NAME:**

The name of the Corporation is **CubFlyers of Sebring, Inc.**

**ARTICLE II - CORPORATE EXISTENCE:**

The period of existence shall be perpetual.

**ARTICLE III - CORPORATE PURPOSE:**

The purposes shall be to engage in any lawful activities authorized by Chapter 617 of the Florida Statutes. The Corporation shall operate as an aircraft flying club organized exclusively for pleasure, recreation and other non-profitable purposes within the meaning of section 501(c)(7) of the Internal Revenue Code of 1986, as amended.

**ARTICLE IV - OPERATIONAL LIMITATIONS:**

Notwithstanding any other provisions of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on by a corporation recognized as operating under section 501(c)(7) of the Internal Revenue Code of 1986, as amended (or the corresponding provision of any future United States Internal Revenue Law).

**ARTICLE V - PRINCIPAL OFFICE:**

## **ARTICLE VII - AMENDMENT OF ARTICLES**

These articles may be amended in the manner authorized by law at the time of amendment.

## **ARTICLE VIII - NUMBER OF DIRECTORS**

The number of directors constituting the Board of Directors shall be fixed by By-law, but shall be not less than three (3).

## **ARTICLE IX - ELECTION OF DIRECTORS**

The election of the Board of Directors shall be by majority vote of the Members as described in the By-laws.

## **ARTICLE X - MEMBERSHIP**

Qualification for membership shall be set forth in the By-laws.

## **ARTICLE XI - DISSOLUTION CLAUSE:**

Upon the dissolution of the Corporation, the Board of Directors shall, after paying or making provisions for the payment of all of the Corporation's liabilities, dispose of all of the Corporation's assets exclusively for the purposes of the Corporation in such manner as the Board of Directors shall determine, or to such organization or organizations organized and operated to qualify as an exempt organization or organizations under section 501(c)(7) or 501(c)(3) of the Internal Revenue Code of 1986, as amended (or the corresponding provision of any future United States Internal Revenue Law), as the Board of Directors shall determine. Any such assets not so disposed of shall be disposed of by the Circuit Court of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.
