### SECOND ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF GLADSTONE PARK HOMEOWNERS ASSOCIATION, INC.

Pursuant to the Florida Business Corporation Act, GLADSTONE PARK HOMEOWNERS ASSOCIATION, INC., a Florida not-for-profit corporation (the "Association"), hereby adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The following is hereby added as a new Article IX to the Articles of Incorporation:

### ARTICLE IX

### TERM

The term of the Association shall be perpetual.

SECOND: The following is hereby added as a new Article X to the Articles of

### Incorporation:

### ARTICLE X

### **DUTIES AND POWERS**

The Association is organized and shall exist upon a non-stock basis as a non-profit corporation under the laws of the State of Florida, and no portion of any earnings of the Association shall be distributed or inure to the private benefit of any member, director or officer of the Association. For the accomplishment of its purposes, the Association shall have all of the common law and statutory powers and duties of a corporation, not-for-profit under the laws of the State of Florida, except as limited or modified by these Articles, that certain Declaration of Covenants, Conditions and Restrictions for Gladstone Park (the "Declaration"), or the By-Laws of this Association, and it shall have all the powers and duties reasonably necessary to operate the Association pursuant to the Declaration as it may hereafter be amended, including, but not limited to, the following:

A. To own and convey property;

B. To levy and collect assessments against Members of the Association (as defined in the Declaration) to defray the costs, expenses and losses of the Association, and to use the proceeds of assessments in the exercise of its powers and duties:

C. To own, lease, maintain, repair, replace, add to or operate the Common Areas (as defined in the Declaration);

D. To reconstruct improvements after casualty and to make further capital improvements or additions to the Property;

E. To make, amend and enforce reasonable rules and regulations governing the use of the Common Areas and the operation of the Association;

F. To sue and be sued, and to enforce the provisions of the Declaration, these Articles and the By-Laws of the Association;

G. To borrow or raise money for any purposes of the Association, without limit as to amount; to draw, make, accept, endorse, execute and issue promissory notes, drafts, bills of exchange, warrants, bonds, debentures, and other negotiable or non-negotiable instruments and evidences of indebtedness; and to secure the payment of any thereof, and of the interest thereon, by mortgage, pledge, conveyance or assignment in trust, of the whole or any part of the rights or property of the Association;

H. To hold funds and the title to all property acquired by the Association for the benefit of the Members in accordance with the provisions of the Declaration, these Articles of Incorporation, and the By-Laws;

I. To operate and maintain the Water Management System, including all inlets, ditches, swales, culverts, water control structures, retention and detention areas, ponds, lakes, flood plan compensation areas, wetlands and any associated buffer areas, and wetland mitigation areas. Moreover, the Association shall operate, maintain, and manage the Water Management System in a manner consistent with Southwest Florida Water Management District ("SWFWMD") permit requirements and applicable District rules and regulations, and the terms and conditions of the Declaration (including enforcement provisions) which relate to the Water Management System. Additionally, the Association shall levy and collect adequate assessments against Members for the cost of maintenance and operation of the Water Management System, which assessments shall be used for the maintenance and operation of the Water Management System and mitigation or preservation areas, including, but not limited to, work within retention areas, drainage structures and drainage easements;

J. To take any other action necessary for the purposes for which the Association organized; and

K. To exercise any and all rights set forth in the Florida Statutes.

**THIRD:** The following is hereby added as a new Article XI to the Articles of Incorporation:

### ARTICLE XI

### AMENDMENTS

Amendments to these Articles shall be proposed and adopted in the following manner:

A. Until Turnover of Control (as defined in the Declaration), the Declarant under the Declaration shall have the unilateral right to amend these Articles.

B. After election of a majority of the Board other than by the Declaration, amendments to these Articles may be proposed either by a majority of the whole Board or by a petition signed by the Members representing at least fifty percent (50%) of the voting interests of the Association. Once so proposed, the amendments shall be submitted to a vote of the Members no later than the next annual meeting for which proper notice can be given.

C. After election of a majority of the Board by Members other than by the Declarant, these Articles of Incorporation may be amended by a vote of two-thirds (2/3) of the Members present and voting at a special or annual meeting at which a quorum has been established. Any such amendment may

also be approved in writing by a majority of the total voting interests without a meeting. Notice of any proposed amendment must be given to the Members, and the notice must contain the text of the proposed amendment.

D. Any proposed amendment to these Articles, which would affect the Water Management System (including environmental conservation areas and the water management portions of the Common Areas), must be submitted to the SWFWMD or its successors for a determination of whether the amendment necessitates a modification of the surface water management permit.

E. An amendment shall become effective upon filing with the Secretary of State and recording a certified copy in the Public Records of Sarasota County, Florida.

FOURTH: The following is hereby added as a new Article XII to the Articles of Incorporation:

### **ARTICLE XII**

### DISSOLUTION

In the event of termination, dissolution or final liquidation of the Association, the responsibility for the operation and maintenance of the Water Management System must be transferred to and accepted by an entity which complies with Rule 62-330.310, Florida Administrative Code, and Applicant's Handbook Volume I, Section 12.3, and must be approved by SWFWMD prior to such termination, dissolution or liquidation.

**FIFTH:** The foregoing amendment to the Association's Articles of Incorporation was adopted and approved by the Board of Directors by written consent effective as of November 6, 2023, and the number of votes cast for the amendment were sufficient for approval.

**SEXTH:** The foregoing amendment to the Association's Articles of Incorporation will become effective upon the filing of these Second Articles of Amendment to Articles of Incorporation with the Florida Department of State.
