ATTACHMENT TO AMENDMENT OF ARTICLES CHRISTIAN SOLDIERS MINISTRIES, INC.

ARTICLE III – PURPOSE Change to read as follows:

This corporation is organized and operated exclusively for religious and educational purposes within the meaning of section 501(c)(3) of the Internal Revenue Code. To promote the gospel of Jesus Christ through education, exhortation, & publication.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue law) or (b) by a corporation contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code of 1986 (or corresponding provision of any future United States Internal Revenue Law).

ARTICLE OF DISSOLUTION Change to read as follows:

Be it amended that upon dissolution of this corporation, assets shall be distributed to "Life Management Ministries, Inc." a not-for-profit corporation registered and incorporated in the state of Florida which is exempt within the meaning of Section 501(c)(3) of the Internal Revenue Code, so long as it remains exempt per IRC 501(c)(3).

Otherwise, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code (or corresponding section of any future federal tax code), or shall be distributed to the Federal government, or to a state or local government for public purpose. Any such assets not so disposed of shall be disposed by the Court of Common Pleas of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
