# ARTICLES OF AMENDMENT TO THE AMENDED AND RESTATED ARTICLES OF INCORPORATION

Pursuant to the provisions of Sections 617.0701, 617.1002 and 617.1006 of the Florida Not for Profit Corporation Act (the "Act"), the members of the board of directors of Spectrum Health, Inc.
