**ARTICLES OF AMENDMENT
TO THE
AMENDED AND RESTATED
ARTICLES OF INCORPORATION
OF
SPECTRUM HEALTH, INC.
(A Florida Not For Profit Corporation)

Pursuant to the provisions of Sections 617.0701, 617.1002 and 617.1006 of the Florida Not for Profit Corporation Act (the "Act"), the members of the board of directors of Spectrum Health, Inc. (the "Corporation"), a corporation organized and existing under and by virtue of the Act, have adopted the following Articles of Amendment to the Corporation's Amended and Restated Articles of Incorporation (the "Amendment") as follows:

1. The Articles of Incorporation of the Corporation were filed on November 17, 2005, and assigned Document Number: N05000011662. The Articles of Incorporation were Amended and Restated on December 15, 2009.

2. The Amended and Restated Articles of Incorporation of the Corporation are hereby amended by deleting Article I thereof in its entirety and substituting the following in its place:

"ARTICLE I

NAME; REGISTERED AND PRINCIPAL OFFICE; REGISTERED AGENT

The name of this Corporation (hereinafter called the Corporation) is "TrustBridge, Inc." The principal office of the Corporation is located at 5300 East Avenue, West Palm Beach, Florida 33407. The registered office is 5300 East Avenue, West Palm Beach, Florida 33407, and the registered agent at such address shall be Michele O'Donnell."

3. The Corporation has no members. The foregoing amendment was approved by resolutions of the board of directors of the Corporation, effective as of September 11, 2013.

4. The effective date and time of this Amendment shall be upon filing with the Florida Secretary of State.
