## ARTICLES OF INCORPORATION

The undersigned, pursuant to Chapter 617, F. S. Nonprofit Corporation Code of **FLORIDA:**

**ONE:**

The **name** of the corporation shall be **CHOSEN GENERATION, INC.**

**TWO:**

The address of the **principal office** of the nonprofit corporation is 4827 Crawfordville Rd. Tallahassee, FL 32305.

**THREE:**

The **purpose** for which the corporation is organized and operated is exclusively for charitable and educational purposes within the meaning of the IRC Section 501(c)(3). Said corporation is a Faith Based Organization established to provide programs that will meet social demands and make provision for the needy. Programs may consist of, but shall not be limited to, Feeding the Hungry, Relief of the Poor and Suffering, Childcare, etc., including, for such purposes, the making of distributions to exempt organizations under the IRC Section 501(c)(3)

**FOUR:**

**Directors shall be elected in accordance with By-Laws.** The Board of Directors shall consist of no less than three (3) directors as determine by law. The names and addresses of the **initial directors** are as follows:

**FIVE:**

No part of the net earnings of the corporation shall inure to the benefit of or be distributed to its members, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Three hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding, any other provision of these articles, this corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under the IRC Section 501(c)(3), or (b) by a corporation, contributions to which are deductible under the IRC Section 170(c)(2).

**SIX:**

The term for which the corporation is to exist shall be perpetual. Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of the IRC Section 501(c)(3), or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

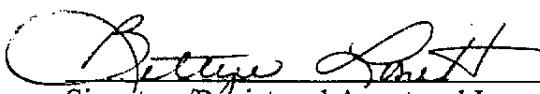
