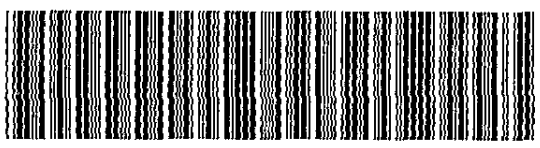

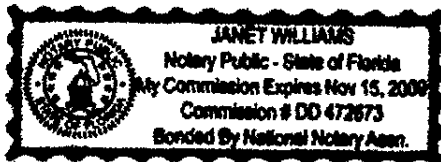

ARTICLE I NAME




