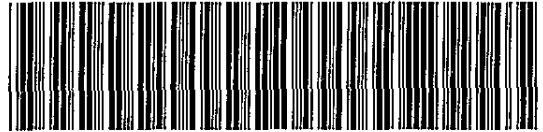

The undersigned, for the purpose of forming a not for profit corporation under the provision of Chapter 617 of the Florida Statutes, hereinafter referred to as the Corporation, hereby agrees to the following:

ARTICLE I - NAME

The name of the Corporation shall be T. BRADLEY ENTERPRISES, INC.

ARTICLE II - PURPOSE AND POWERS

The purpose of the Corporation shall be as follows:

A. To receive and administer funds and to operate exclusively for educational purposes within the meaning of Section 501.(C)(3) of the Internal Revenue Code of 1986, as the same may be revised from time to time, including among those purposes, as the same may be revised from time to time, including among those purposes mentoring, tutorial, testing preparation of children and adults for educational purposes.
