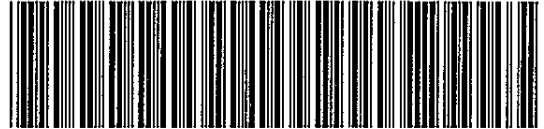

ARTICLES OF INCORPORATION

Pursuant to Chapter 617.0202, F.S. (Not for Profit) the Articles of Incorporation for Faith Gathering Prison Ministry Services Corporation

ARTICLE I NAME

The name of the corporation shall be:

Faith Gathering Prison Ministry Services Corporation

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

ARTICLE III PURPOSE

The purpose for the organization of this corporation is:

Faith Gathering Prison Ministry Services Corporation is a not-for-profit religious organization responding to the unique needs of children of God anywhere by providing spiritual, educational, humanitarian and advocacy services to people and their families who are homeless, hungry and unemployed as well as those in hospitals, shelters and federal prison.

Faith Gathering Prison Ministry Services Corporation defines "Children of God" as anyone who has tradition and faith in God Almighty. We serve the Children of God who have a Christianity or Judaism tradition. We do not prescribe to any one denomination. Rather, we respect all religious faiths and traditions of people who have accepted Jesus Christ as their personal Lord and Savior and/or the tradition of Judaism. With great zeal, we respond to the genuine needs of Jewish individuals.

ARTICLE IV MANNER OF ELECTION

The manner in which the Directors are elected or appointed:

All Directors for the Faith Gathering Prison Ministry Services Corporation are appointed by the Senior Reverend and Sagest for Faith Gathering Prison Ministry Services Corporation.

Elections are made by the Directors Committee (see below) which may contain no more than seven (7) Directors at any one time and shall elect and nominate Director candidates. The Director Committee may elect, nominate and present no more than two (2) Director candidates at one time to the Senior Reverend and Sagest. The Director Committee is permitted to submit Director candidate presentations to the Senior Reverend and Sagest for review and consideration a maximum of two (2) times a year.

Any nominated Director candidate not approved and appointed by the Senior Reverend and Sagest must wait a minimum of one (1) year before reconsideration and he/she must be elected, nominated and presented, again, by

the Faith Gathering Prison Ministry Services Corporation Directors Committee to the Senior Reverend and Sagest for approval and appointment. Approvals and appointments made by the Senior Reverend and Sagest are final.

The Directors Committee will consist of:

1. No more than three (3) Deacons; male or female
2. No more than two (2) Disciples; male or female
3. No more than one (1) Elder; male or female
4. No more than one (1) Sagest; male or female

All Directors will serve a term of no more than three (3) years and cannot be re-appointed until after completion of a full three (3) year waiting period; no exceptions.

An election and nomination is a decision made by the Directors Committee. All decisions and orders approved by the Directors of Faith Gathering Prison Ministry Services Corporation must be presented to the Senior Reverend and Sagest of their designatee in a report form. Each Director of Faith Gathering Prison Ministry Services Corporation must attach a personalized report that is to be sealed, covered and handed directly to Faith Gathering Prison Ministry Services Corporation Senior Reverend and Sagest or their designatee, as directed by the Senior Reverend and Sagest. All personalized reports must be turned in to the Senior Reverend and Sagest or their designatee within forty-eight (48) hours of any final decision made by the Directors Committee for Faith Gathering Prison Ministry Services Corporation. Without exception, at not time is a copy of a Directors personalized report to be given to another Director of Faith Gathering Prison Ministry Services Corporation or anyone else. The Senior Reverend and Sagest or the designatee will be given thirty (30) days from the time all personalized reports are submitted to give a final decision or recommendation. All decisions and orders require the full approval of the Senior Reverend and Sagest. All recommendations made by the Senior Reverend and Sagest will be given to the Directors Committee and they will be given a review and response time as outlined in the recommendation report.




