**ARTICLES OF INCORPORATION
OF
IN CHRIST MINISTRIES OF PONTE VEDRA BEACH, INC.**

The undersigned, acting as incorporators of a Corporation pursuant to Chapter 617, Florida Statutes, adopt the following Articles of Incorporation of Such Corporation:

ARTICLE I

The name of the Corporation shall be IN CHRIST MINISTRIES OF PONTE VEDRA BEACH, INC.

The principal place of business of this corporation shall be: 101 Osprey Ridge Way, Ponte Vedra Beach, Florida 32082.

ARTICLE II

The period of the duration of this corporation is perpetual unless dissolved according to law, effective upon filing with the Secretary of State of the state of Florida.

ARTICLE III

The purposes for which this corporation is organized are to provide Christian mentoring, discipleship and guidance through study of the New Testament. The purposes for which this corporation is organized are exclusively charitable and educational within the meaning of Section 501 (c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

ARTICLE IV

The qualifications for members and the manner of their admission are: all individuals interested in the purposes of this corporation shall be eligible for membership.

ARTICLE V

The number constituting the initial Board of Directors of the Corporation shall be a minimum of three (3). The manner in which the directors are to be elected or appointed shall be set forth in the bylaws of the Corporation.

ARTICLE VI

This corporation is organized under a non-stock basis.

ARTICLE VII

Notwithstanding any other provisions of these articles, this Corporation shall not carry on any activities not permitted to be carried on by a corporation exempt from Federal Income Tax under Section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provisions of any future United States Internal Revenue law.


